AN ORDINANCE FIXING THE GRADE OF NORTH WARREN STREET AND PROVIDING FOR THE INSTALLATION, REPLACE-MENT AND REPAIRING OF CURBS ALONG WARREN STREET.

BE IT ENACTED and ORDAINED by the Borough Council of the Borough of Orwigsburg, Schuylkill County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same, as follows:

Section 1. The grade of North Warren Street in the Borough of Orwigsburg from a point 1,060 feet north of East Tammany Street, northwardly for a distance of 1,125 feet, on North Warren Street shall be as follows:

- (a) On the west side of the said street beginning at the end of the existing curb, northwardly, the grade shall be =.0119% for 107.95 feet, then + 4.1133% for 150 feet; then =2.692% for 500 feet; then + 5.9629% for 270 feet; then + 8.37% for 80 feet to station 16+00.
- (b) On the east side of the said street beginning at the end of the existing curb, northwardly the grade shall be =.0119% for 128.16 feet; then +4.1133% for 150 feet; then +2.692% for 500 feet; then +5.9629% for 270 feet; then +8.37% for 80 feet to station 16+00 as set forth in detailed map or plan as made by Walter J. Manhart Reg. Surveyor No. 14708E Dated 10, 1973.

Section 2. The map or plan of North Warren Street with the lines and grades hereof, is on file in the office of the Borough Manager and is made a part thereof as though the same were included in this Ordinance.

Section 3. All property owners along the east and west sides of North Warren Street from a point 1,060 feet north of East Tammany Street northwardly for a distance of 1,125 feet are hereby required to replace and install curbs along their respective properties. The Borough Manager is hereby authorized to inspect all curbs along the east and west sides of North Warren Street and determine which curb shall be replaced and which shall be repaired, and which are found in sufficiently good condition to meet the requirements of the Ordinances of the Borough of Orwigsburg. The Borough Manager is hereby authorized to notify the respective property owners, by registered mail at their last known address, that said property owner shall install or repair said curb within a period of thirty (30) days from the receipt of said notice. Said curb shall be constructed in compliance with the Ordinances of the Borough of Orwigsburg, as amended.

Section 4. All Ordinances or resolutions, or parts of Ordinances resolutions, in so far as they are inconsistent herewith be in the same are hereby repealed.

Section 5. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Borough Council and the Mayor of the Borough of Orwigsburg that this Ordinance would have been adopted had such unconstitutional, illegal or invlid sentence, clause, section, or a part thereof not been included therein.
