ORDINANCE NO. 214

AN ORDINANCE AMENDING ORDINANCE NO. 194 OF THE BOROUGH OF ORWIGSBURG, AND PROVIDING FEES FOR BUILDING PERMITS.

BE IT ENACTED and ORDAINED by the Council of the Borough of Orwigsburg, County of Schuylkill and State of Pennsylvania, and it is hereby enacted and ordained by the authority of the same, as follows:

Section 1. That Section 3 of Ordinance No. 194 of the Borough of Orwigsburg is hereby amended as follows:

Section 3. All permits for the purposes set forth in Section 1 hereof shall be issued by the Borough Manager or such other officer as the borough council shall from time to time direct, upon the filing of an application on a form or forms to be supplied by the Borough on request. The application form shall contain in summary the nature, extent and estimated information deemed essential or pertinent thereto. The permit shall not be issued until a fee is paid based upon the contract price of such work if a contract shall have been agreed upon, otherwise upon the estimated value of such work, as follows:

<u>Contract price or estimated cost</u>	<u>Fee</u>
\$ 0 - \$ 25,000	\$ 5.00
\$25,000 - \$ 50,000	\$10.00
\$50,000 - \$100,000	\$20.00
Over \$100,000	\$25.00

Section 2. The remaining sections of Ordinance No. 194 as amended shall remain in full force and effect.

Section 3. Any ordinance or part of an ordinance conflicting with this ordinance is hereby repealed insofar as the same affects this ordinance.

Section 4. If any sentence, clause, section or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, invalidity or illegality shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this ordinance. It is hereby declared as the intent of the Borough Council and Mayor of the Borough of Orwigsburg that this ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.
