ORDINANCE NO. 266

AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 177 PRESCRIBING PARKING AND TRAFFIC REGULATIONS IN THE BOROUGH OF ORWIGSBURG AND PROVIDING FOR PENALTIES FOR THE VIOLATION THEREOF.

BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Orwigsburg, Schuylkill County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same, as follows:

Ordinance No. 177 prescribing parking and traffic regulations in the Borough of Orwigsburg is amended as follows:

SECTION 1. Article III, section 3 is hereby amended to establish the following stop intersection:

MARGARET AVENUE AND JACK'S LANE

(a) At the southwest corner of its intersection with Jack's Lane for eastbound traffic on Margaret Avenue.

(b) At that the northeast corner of its intersection with Jack's Lane for westbound traffic on Margaret Avenue.

SECTION 2. Article IV is amended to regulate parking on North Liberty Street between West Market Street and Cherry and on West Market Street as follows:

(a) A loading zone shall be established on North Liberty Street beginning at a distance of 23 feet from the cross walk on the northeast corner of North Liberty And Market Street and shall extend for a period of 28 feet, said area to be designated by official signs to be erected on North Liberty Street.

(b) A parking zone shall be established on North Liberty Street, commencing at a distance of 51 feet from the cross walk on the northeast corner of North Liberty Street and extending to 15 feet South of the intersection of Cherry Street. Parking shall further be established on the east side of North Liberty Street from Cherry Street to Mifflin Street.

(c) A "No Parking - Tow Away Zone" shall be established on West Market Street on the northeast corner of its intersection with North Liberty Street, said area to be designated by an official traffic to be erected on West Market Street.

SECTION 3. All ordinances or parts of ordinances of the Borough of Orwigsburg in conflict herewith are hereby expressly repealed.

SECTION 4. This ordinance shall be become effective on the 9th of April, 1986, or at such time as official signs shall be erected on the streets affected by any of the sections of this ordinance.
