ORDINANCE NO. 309

AN ORDINANCE OF THE BOROUGH OF ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA, LIMITING THE USE OF SKATEBOARDS IN THE BOROUGH

BE IT ENACTED AND ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA, and it is hereby ENACTED AND ORDAINED by the Authority of the same as follows:

- Section 1.00 Skateboard Defined. A vehicle propelled by human power and gravity consisting of material or portion of material formed in a thin firm sheet with wheels attached to the underside.
- Section 2.00 Prohibited locations. It shall be unlawful for any person to engage in skateboarding or ride upon, or propel any skateboard upon public thoroughfare, street, sidewalk and Borough property in the Borough of Orwigsburg.
- <u>Section 3.00</u> Ramps and Devices. No person shall place a ramp, halfpipe or other structure used for skateboarding in a public thoroughfare, street, upon a sidewalk or Borough property lot within the Borough of Orwigsburg.
- <u>Section 4.00</u> Violations and Penalties. Any person who shall violate any of the provisions of this Ordinance shall, upon conviction thereof:
 - a. First Offense. The skateboard used in violation of this ordinance shall be impounded by the Police Department of the Borough for a period not exceeding fifteen(15) days. If the person violating the Ordinance is a minor, in addition to the confiscation of the skateboard as aforementioned, the Borough Police shall notify the parents, guardian, or other person having legal custody of said minor of the violation of this Ordinance and the inpounding of the skateboard. In addition, said individual shall be provided with a copy of this Ordinance.
 - b. Second and/or Subsequent Offense. The skateboard of any person violating the provisions of this Ordinance for the second and/or subsequent time shall be impounded by the Police Department of the Borough of Orwigsburg, and a fine of \$25.00 to \$100.00 shall be levied. Upon disposition of the fine, the skateboard will be returned.
