**ORDINANCE NO. 332**

AN ORDINANCE OF THE BOROUGH COUNCIL OF THE  
BOROUGH OF ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA,  
PROVIDING FOR THE ASSESSMENT OF ATTORNEY'S FEES  
AND ESTABLISHING A SCHEDULE OF ATTORNEY'S FEES  
INCURRED IN THE COLLECTION OF ANY DELINQUENT  
ACCOUNT AND THE FILING OF A MUNICIPAL CLAIM

**BE IT ENACTED** and **ORDAINED** by the Borough Council of the Borough of Orwigsburg, Schuylkill County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

**SECTION 1:** Pursuant to Act No. 1996-1, the Act of May 16, 1923 (P.L. 207, No. 153), referred to as the Municipal Claim and Tax Lien Law, was amended to provide for the recovery of all charges, expenses and fees incurred in the collection of any delinquent account of the Borough, including reasonable attorney's fees. Pursuant thereto, the Borough Council of the Borough of Orwigsburg hereby adopts a schedule of fees relative to Municipal Claims and Liens.

**SECTION 2:** The Borough Council specifically authorizes a charge of \$75.00 for the preparation and filing of a Municipal Claim or Lien, and authorizes the assessment of the same against the property owner in the Municipal Claim. All other legal services rendered in connection with the collection and enforcement of Municipal Claims shall be assessed against the property owner on a time basis at a rate of \$75.00 per hour.

**SECTION 3:** All ordinances or parts of ordinances of the Borough of Orwigsburg in conflict herewith be and the same are hereby repealed.

**SECTION 4:** The fee schedule established in this Ordinance may be amended from time to time by resolution of the Borough Council of the Borough of Orwigsburg.

SECTION 5: This Ordinance shall become effective upon its adoption by the Borough Council of the Borough of Orwigsburg.
