**ORDINANCE NO. 454**

**AN ORDINANCE RATIFYING AND CONFIRMING MARSHALL DRIVE  
AS A PUBLIC STREET OF THE BOROUGH OF ORWIGSBURG,  
SCHUYLKILL COUNTY, PENNSYLVANIA; AND PROVING FOR  
REPEALER, VALIDITY AND THE EFFECTIVE DATE OF THE  
ORDINANCE.**

WHEREAS, Marshall Drive within the Borough of Orwigsburg has been previously laid out, opened and accepted as a public street in the Borough of Orwigsburg and appear in the plans of the Borough of Orwigsburg, and

WHEREAS, the Borough Council desires to ratify and confirm Marshall Drive as a public street in the Borough of Orwigsburg.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Orwigsburg, Schuylkill County, Pennsylvania, and it is hereby enacted and ordained by authority of the same as follows:

**SECTION 1. RATIFICATION AND CONFIRMATION OF MARSHALL DRIVE.**

1.1 Marshall Drive in the Borough of Orwigsburg, as previously laid out, opened and ordained, is hereby ratified and confirmed as a public street in the Borough of Orwigsburg, extending from its intersection with Ridge Road in a northerly direction, a distance of 1,060 feet, more or less, to the dead end past its intersection with Halsey Drive.

1.2. The right-of-way of Marshall Drive, as set forth in Section 1 shall be fifty (50) feet and the roadway width shall be thirty (30) feet to Eisenhower Drive with a right-of-way of fifty (50) feet and the roadway width thirty (30) feet from Eisenhower to the dead end past its intersection with Halsey Drive.

**SECTION 2. REPEALER.** All Ordinances or Resolutions, or parts of Ordinances or Resolutions, in so far as they are inconsistent herewith, shall be and the same are hereby repealed.


**SECTION 3. VALIDITY.** If any section or part of a section of this Ordinance shall be declared invalid, such invalidity shall not affect the remaining parts or section of this Ordinance. It is hereby declared to be the legislative intent that this Ordinance would have been enacted as if such invalid section, or portion thereof, had not been included therein.


**SECTION 4. EFFECTIVE DATE.** This Ordinance shall become effective upon enactment.

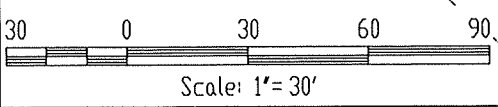
