ORDINANCE NO. 197

AN ORDINANCE APPROVING THE PETITION FOR ANNEXATION TO THE BOROUGH OF ORWIGSBURG, A SECTION OF WEST BRUNSWICK TOWNSHIP, SCHUYLKILL COUNTY, PENNSYLVANIA, ADJACENT TO THE BOROUGH OF ORWIGSBURG, AND HEREINAFTER MORE FULLY DESCRIBED; PROVIDING THAT SAID TERRITORY SHALL BE ANNEXED TO AND BECOME A PART OF THE BOROUGH OF ORWIGSBURG.

WHEREAS, the majority of the freeholders of the land hereinafter described, situate in the Township of West Brunswick, County of Schuylkill and State of Pennsylvania, a Second Class Township of the Commonwealth of Pennsylvania, which land is adjacent to the Borough of Orwigsburg, have petitioned the Borough Council of the Borough of Orwigsburg, requesting the annexation of said territory; and

WHEREAS, the Borough Council of the Borough of Orwigsburg has considered said petition at a regular meeting of its Borough Council held October 8, 1969.

NOW, THEREFORE, BE IT ENACTED and ORDAINED, and it is hereby enacted and ordained by the Borough Council of the Borough of Orwigsburg, as follows:

Section 1. The Borough of Orwigsburg hereby approves the petition of the freeholders of the territory proposed to be annexed to said borough, being that portion of West Brunswick Township, Schuylkill County, Pennsylvania, a township of the second class, which territory is adjacent and contiguous to the Borough of Orwigsburg, and is bounded and described as follows:

"ALL THAT CERTAIN lot or parcel of ground situate in the Township of West Brunswick, Schuylkill County, Pennsylvania, bounded and described as follows:

BEGINNING at a concrete monument located on the North right-of-way line of P. D. H., L. R. #53014, said monument being the Southeast

authority contained in the Local Tax Enabling Act, 1965, December 31, P. L. 1257, as amended.

SECTION XIV. EFFECTIVE DATE.

The provisions of this ordinance shall become effective January 1, 1970.

SECTION XV. REPEALER.

Any resolution or ordinance, or parts of resolutions or ordinances, conflicting with the provisions of this ordinance are hereby repealed, insofar as the same may affect the terms of this ordinance.
