ORDINANCE NO. 276

AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF ORWIGSBURG AMENDING ORDINANCE NO. 158 INCREASING THE MEMBERSHIP OF PLANNING COMMISSION OF THE BOROUGH OF ORWIGSBURG FROM FIVE (5) TO SEVEN (7) MEMBERS.

BE IT ENACTED and ORDAINED by the Borough Council of the Borough of Orwigsburg, Schuylkill County, Pennsylvania, in council duly assembled, and it is hereby enacted and ordained by the authority of the same, as follows:

SECTION 1. Section 2 of Ordinance No. 158 be and hereby is amended as follows.

Section 2. The Borough Planning Commission shall consist of seven (7) resident taxpayers of the Borough of Orwigsburg, who shall be appointed by the Borough Council of the Borough of Orwigsburg as provided by law and shall perform all of the duties and may exercise all of the powers vested in law in Municipal planning agencies, provided: The members of the Borough Planning Commission in office at the time of the enactment of this Ordinance shall constitute the present members of the Planning Commission established by this Ordinance and nothing herein shall affect the tenure of any member of such present Planning Commission, but two (2) new appointments in such membership shall be made by the Borough Council as follows:

- (1) One Member to serve until the first Monday in January 1990.
- (2) One Member to serve until the first Monday in January 1991.

Upon the expiration of the respective terms of office of the present and newly appointed members, the Borough Council shall, on the first Monday of January of each year, make such appointments and fill such vacancies in accordance with the applicable provisions of the law in effect at the time of such vacancies. In the event of a vacancy by causes other than the expiration of the term of which a

member shall have been appointed, the Borough Council shall fill such vacancy for the unexpired portion of said term.

SECTION 2: All Ordinances or Resolutions or parts of Ordinances or Resolutions insofar as they are consistent herewith being the same are hereby repealed.

SECTION 3: This Ordinance shall become effective immediately upon adoption.
