ORDINANCE NO. 295

AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF ORWIGSBURG
AMENDING ORDINANCE NUMBER 194, 214, AND 227 OF THE BOROUGH OF
ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA, AND PROVIDING FOR
A FEE FOR BUILDING PERMITS

BE IT ENACTED AND ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH
OF ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA, and it is hereby
ENACTED and ORDAINED by the Authority of the same, as follows:

SECTION 1.00

Section 3 of Ordinance No. 194 of the Borough of Orwigsburg, as amended by Section 1 of Ordinance No. 214 and Section 1 of Ordinance No. 227, is hereby further amended as follows:

Section 3. All permits for the purposes set forth in Section 1 hereof shall be issued by the Zoning Officer or such other Officer as the Borough Council shall, from time to time, direct, upon the filing of an application on a form or forms to be supplied by the Borough on request. The application form shall contain in summary the nature, extent and estimated information deemed essential or pertinent thereto. The permit shall not be issued until a fee is paid based upon the contract price of such work if a contract shall have been agreed upon, otherwise upon the estimated value of such work to be estimated by the Borough in accordance with the current BOCA Building Valuation Data Report, which is hereby adopted and incorporated herein by reference as if fully set forth at length. The Borough reserves the right to utilize the BOCA Building Valuation Data Report for the purpose of verifying and confirming contract prices and may amend the building permit fee in accordance therewith.

The building permit rate schedule is as follows:

<u>Contract Price of Estimated Cost</u>	<u>FEE</u>
\$ 0 - \$ 999	\$ 5.00
\$1,000 - \$1,999	\$10.00
\$2,000 - \$2,999	\$15.00
\$3,000 - \$3,999	\$20.00
\$4,000 - \$4,999	\$25.00
Over \$5,000	\$ 4.00 per \$1,000

The building permit fee schedule set forth above may be amended from time to time by Resolution of the Borough Council of the Borough of Orwigsburg.

SECTION 2.00

The remaining sections of Ordinance No. 194 as amended shall remain in full force and effect.

SECTION 3.00


Any Ordinance or part of any Ordinance conflicting with this Ordinance is hereby repealed insofar as the same affects this Ordinance.

SECTION 4.00


