ORDINANCE NO. 296

AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF ORWIGSBURG,
SCHUYLKILL COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 268

BE IT ENACTED AND ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH
OF ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA, and it is hereby
ENACTED and ORDAINED by the Authority of the same, as follows:

SECTION 1.00

Section 3 of Ordinance No. 268 of the Borough of Orwigsburg
is hereby amended as follows:

Section 3. Computation of Service Charge: The service charge
shall be computed as indicated in the Sewer Management Plan,
dated February 1986, prepared by PSC Environmental Services, Inc.
under the following categories:

(1) Residential dwelling units within the Borough, either
existing homes, apartments, lots or other dwelling units accessible
to existing sewer mains: The Landowner shall be charged for one
(1) EDU for each house, apartment, or other dwelling unit connected
to the public sewage system.

(2) Residential dwellings within the Borough, new construction
by developers not accessible to existing sewer mains: Under the
Borough of Orwigsburg "Standard Specification for Developers",
developers are required to install all sewer mains and service
connections to the properties to be served at their own expense.
Developers shall be charged for one (1) EDU for each house, apartment
or dwelling unit on the approved plan to be served by the sewer system.

(6) Residential dwellings outside the Borough and not accessible
to existing sewer: A service charge shall be computed in the same
manner as in Subsection (2) above, with an additional fee of \$525.00
per EDU, together with payment of all costs involved with regard to
the extension of the sewer system and sewer connection.

(7) Industrial and Commercial development outside the Borough and not accessible to existing sewer: The computation shall be made as outlined in Subsection (5) above, with the additional fee of \$525.00 per EDU, together with payment of all costs involved with regard to the extension of the sewer system and sewer connection. The service charge imposed hereby and computation of the service charge set forth above may be amended from time to time by Resolution of the Borough Council of the Borough of Orwigsburg.

The term "dwelling unit" means each room, group of rooms, building, housetrailer, or other enclosure occupied or intended for occupancy as a separate living quarters by a family or other group of persons living together or by a person living alone.

SECTION 2.00

The remaining sections of Ordinance No. 268 shall remain in full force and effect.

SECTION 3.00

Any Ordinance or part of an Ordinance conflicting with this Ordinance is hereby repealed insofar as the same affects this Ordinance.


SECTION 4.00

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, invalidity, or illegality shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Borough Council and Mayor of the Borough of Orwigsburg that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.


