ORDINANCE NO. 307

AN ORDINANCE OF THE BOROUGH COUNCIL OF THE BOROUGH OF ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA, AMENDING THE ZONING CLASSIFICATION FROM INDUSTRIAL (I) TO MEDIUM-DENSITY RESIDENTIAL (R-2) FOR THE PROPERTY IDENTIFIED ON THE TAX MAP AS PARCEL # 56-2-126 IN THE BOROUGH OF ORWIGSBURG AND AMENDING THE OFFICIAL MAP TO REFLECT THE CHANGE IN ZONING CLASSIFICATIONS.

WHEREAS, on or about March 27, 1991, the Borough Council of the Borough of Orwigsburg received an Amended Petition requesting the Borough Council to amend the zoning classification of certain property identified on the Tax Map as parcel 56-2-126; and

WHEREAS, the Planning and Zoning Commission of Orwigsburg Borough on Wednesday, March 20, 1991 voted to recommend to the Borough Council to grant the request of the Petitioners to amend the zoning classification from its existing Industrial (I) to Medium-density Residential (R-2) zoning classification;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE AUTHORITY OF THE SAME AS FOLLOWS:

1. The following area situate in Orwigsburg Borough, Schuylkill County, Pennsylvania, is hereby re-classified and re-zoned Medium-density Residential (R-2) from its existing classification of Industrial (I) : all that property identified on Orwigsburg Borough Tax Map as parcel 56-2-126.

2. A copy of the adopted Ordinance shall be forwarded to the Schuylkill County Planning Commission within Thirty (30) days after enactment, in accordance with Article VI, Section 608 (g) of the Pennsylvania Municipalities Planning Code Act of 1968, P.L. 805 No. 247, re-enacted and amended December 21, 1980, P.L. No. 170.

3. The Orwigsburg Borough records and official maps are hereby amended to reflect the above change of zoning classification for the area in question.
