

BOROUGH OF ORWIGSBURG
ORDINANCE NO. 335

AN ORDINANCE AMENDING ORDINANCE NUMBER 318 WHOSE SHORT TITLE IS "ORWIGSBURG BOROUGH ZONING ORDINANCE" BY REZONING CERTAIN AREAS IN THE BOROUGH AS FOLLOWS:

BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Orwigsburg, Schuylkill County, Pennsylvania, and it is hereby enacted and ordained as follows:

The Zoning map of the Borough of Orwigsburg is amended as follows:

The tract of land recorded in Book 1430 Page 0809 in the Schuylkill County Courthouse described below shall be rezoned from Commercial to residential:

Beginning at a point in line of St. Francis' Orphan Asylum, said point also being on the North side of a former twenty five (25) wide road on the plot of lots of Sallie E. Peifley; thence along land of St. Francis' Orphan Asylum, North fourteen (14) degrees, seventeen (17) minutes West two hundred (200) feet, more or less, to an iron stake close to the creek at the North side of said parcel; thence along land formerly Sallie E. Peifley conveyed to St. Francis' Orphan Asylum on September 14, 1949, North seventy six (76) degrees fifty eight (58) minutes East one hundred eighty six feet (186) feet, more or less, to the west side of a fifty (50) feet wide street; thence along said fifty (50) feet wide street, South fourteen (14) degrees eight (8) minutes East two hundred (200) feet, more or less, to the North side of a twenty-five (25) feet wide street; thence along said former twenty five (25) feet wide road, South seventy five (75) degrees, fifty two (52) minutes West one hundred eighty six (186) feet, more or less, to the place of beginning.

Being that portion to the North of Lots 47, 48, 49, 50, 51, 52, and portion laid out formerly as a road East of St Francis' Orphan Asylum, and being that portion North of the former twenty five (25) feet road and extending two hundred (200) feet, more or less, toward the creek.
