ORDINANCE NO. 338

**AN ORDINANCE TO VACATE A CERTAIN UNOPENED
PORTION OF JONES STREET, ORWIGSBURG,
PENNSYLVANIA.**

An Ordinance providing for the vacating of a certain portion of Jones Street in the Borough of Orwigsburg, Schuylkill County, Pennsylvania, hereinafter described in accordance with the provisions of the Borough Code, Article XVII, Section 46741 et seq. It is hereby enacted and ordained as follows:

Section 1. Council hereby vacates that portion of Jones Street in the Borough of Orwigsburg, Schuylkill County, Pennsylvania, as more particularly described as follows:

ALL THAT CERTAIN piece or parcel of land, situated in the Borough of Orwigsburg, County of Schuylkill, Commonwealth of Pennsylvania, more bound and described as follows to wit:

BEGINNING at the point of intersection of the westerly right-of-way line of Jones Street with the southerly right-of-way line of Cherry Street, thence along the southerly right-of-way line of Cherry Street, South sixty-four degrees thirty minutes zero seconds East, a distance of forty feet to the point of intersection of the southerly right-of-way line of Cherry Street with the easterly right-of-way line of Jones Street;

THENCE along the easterly right-of-way line of Jones Street, South twenty-five degrees thirty minutes zero seconds West, a distance of two hundred two and six tenths feet to the point of intersection of the easterly right-of-way line of Jones Street with the northerly right-of-way line of East Market Street;

THENCE along the northerly right-of-way line of East Market Street, North sixty-four degrees four minutes twenty-five seconds East, a distance of forty feet to the point of intersection of the northerly right-of-way line of East Market Street with the westerly right-of-way line of Jones Street;

THENCE along the westerly right-of-way line of Jones Street, North twenty-five degrees thirty minutes zero seconds East, a distance of two hundred two and three tenths

feet to the place of beginning.

CONTAINING 8,097.95 square feet of land.

Section 2. The Borough Secretary is hereby directed to certify to the adoption of this Ordinance, and to cause the same to be filed with the Clerk of Courts, Schuylkill County, Pennsylvania. This Ordinance shall be effective thirty (30) days after approval is so certified.
