ORDINANCE NO. 351

AN ORDINANCE OF THE BOROUGH OF ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA, FIXING THE TAX RATE FOR THE FISCAL YEAR 2002.

BE IT ENACTED AND ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA, and it is hereby ENACTED and ORDAINED by the Authority of the same as follows:

SECTION 1.00

Property Tax Levy. That a tax be, and the same is hereby levied on all real property within the Borough of Orwigsburg subject to taxation for the fiscal year, 2002, as follows:

The tax rate for General Revenue purposes is the sum of 2.84 (two and 84/100) mills on each dollar of assessed valuation.

SECTION 2.00

Occupation Tax Levy. That a tax be, and the same is hereby levied on all occupations within the Borough of Orwigsburg, subject to taxation for the fiscal year 2002 as follows:

The tax rate for General Revenue purposes is the sum of thirteen (13) mills, on each dollar of assessed valuation:

SECTION 3.00

Discounts. Pursuant of Section 10 of the "Local Tax Collection Law", a taxpayer subject to the payment of a tax levied by this Ordinance shall be entitled to a discount of two per-cent (2%) from the amount of such tax upon making payment of the whole amount of such tax within two (2) months after the date of the tax notice.

SECTION 4.00

Penalties. A taxpayer subject to the payment of a tax levied by this Ordinance who shall fail to make payment of such tax for four (4) months after the date of the tax notice shall be charged a penalty of ten percent (10%), which penalty shall be added to the tax by the Tax Collector and shall be collected by the Tax Collector.

SECTION 5.00

Repealer. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

SECTION 6.00

Severability. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intend of the Borough of Orwigsburg that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not bee included herewith.
