ORDINANCE NO 407

AN ORDINANCE TO VACATE A CERTAIN PAPER ALLEY, BEING A PORTION, OF A THIRTY (30) FOOT WIDE UNOPENED ALLEY KNOWN AS DECATUR STREET WHICH EXTENDS SOUTHWARDLY FROM AND PERPENDICULAR TO EAST MIFFLIN STREET TO INTERSECT WITH EAST CHERRY STREET IN THE BOROUGH OF ORWIGSBURG, SCHUYLKILL COUNTY, PENNSYLVANIA

An Ordinance providing for the vacating of certain paper alleys, being a portion of a thirty (30) foot wide unopened alley known as Decatur Street extending southwardly from and perpendicular to East Mifflin Street to intersect with East Cherry Street in the Borough of Orwigsburg, Schuylkill County, Pennsylvania, hereinafter described in accordance with the provisions of the Borough Code, 53 P.S. Section 45101 *et seq.* It is hereby enacted and ordained as follows:

Section 1. The Borough Council of the Borough of Orwigsburg hereby vacates that portion of a thirty (30) foot wide unopened alley known as Decatur Street southwardly from and perpendicular to East Mifflin Street to intersect with East Cherry Street in the Borough of Orwigsburg, Schuylkill County, Pennsylvania, as more fully shown on a map or plan prepared by Merlyn J. Jenkins & Associates Inc. dated March 5, 2010 know as Drawing SK-2665, a copy of which is attached hereto as Exhibit "A".

Section 2. The Borough Secretary is hereby directed to certify to the adoption of this Ordinance in accordance with the provisions of the Borough Code. This Ordinance shall be effective forty (40) days after approval is so certified.

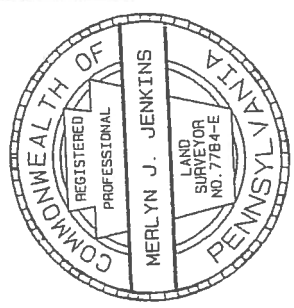
