ORDINANCE NO. 455

**AN ORDINANCE VACATING A PORTION OF ALBERT DRIVE WITHIN
ORWIGSBURG BOROUGH, SCHUYLKILL COUNTY, PENNSYLVANIA,
PREVIOUSLY DEDICATED BUT NOT IMPROVED; AND PROVING
FOR REPEALER, VALIDITY AND THE EFFECTIVE DATE OF THE
ORDINANCE.**

WHEREAS, a portion of Albert Drive within Orwigsburg Borough, Schuylkill County, Pennsylvania, was previously dedicated to the Borough but was not improved and has not been maintained by the Borough, said location being: Albert Drive from the end of the currently paved and improved portion northeasterly to its terminus at UPI No. 56-03-0087.000; and

WHEREAS, in the judgment of the Borough Council of Orwigsburg Borough, said portion of Albert Drive within the Borough is not now nor has it ever been necessary for the public convenience.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Orwigsburg, Schuylkill County, Pennsylvania, and it is hereby enacted and ordained by authority of the same as follows:

SECTION 1. VACATION. With title thereto to revert to the adjoining landowners, the Borough of Orwigsburg hereby vacates a portion of Albert Drive within Orwigsburg Borough, Schuylkill County, Pennsylvania, from the end of the currently paved and improved portion of Albert Drive northeasterly to its terminus at the southern boundary line of UPI No. 56-03-0087.000, as more specifically shown on the Map attached hereto and incorporate herein by reference.

SECTION 2. REPEALER. All Ordinances or Resolutions, or parts of Ordinances or Resolutions, in so far as they are inconsistent herewith, shall be and the same are hereby repealed.


SECTION 3. VALIDITY. If any section or part of a section of this Ordinance shall be declared invalid, such invalidity shall not affect the remaining parts or section of this Ordinance. It is hereby declared to be the legislative intent that this Ordinance would have been enacted as if such invalid section, or portion thereof, had not been included therein.

SECTION 4. EFFECTIVE DATE. This Ordinance shall become effective upon enactment.


